## SECTION 4 - FIRST AID MEASURES

<b>Inhalation</b>	IF INHALED: Remove person to fresh air and keep comfortable for breathing. Immediately call a doctor.
<b>Ingestion</b>	IF SWALLOWED: Rinse mouth. Do NOT induce vomiting. NEVER give anything by mouth if victim is rapidly losing consciousness, or is unconscious or convulsing. Rinse mouth thoroughly with water. Have victim drink two glasses of water. If vomiting occurs naturally, have victim lean forward to reduce risk of aspiration. Call a doctor if you feel unwell.
<b>Skin contact</b>	IF ON SKIN (or hair): Take off immediately all contaminated clothing. Rinse skin with water (15-20 minutes). Wash contaminated clothing before reuse.

## SECTION 5 - FIREFIGHTING MEASURES

<b>Specific hazards of the hazardous product (hazardous combustion products)</b>	Carbon oxides and other irritant/toxic gases and fumes.
<b>Suitable and unsuitable extinguishing media</b>	In case of fire: Use carbon dioxide, chemical powder agent and appropriate foam to extinguish surrounding products.
<b>Special protective equipment and precautions for fire-fighters</b>	During a fire, irritating/toxic smoke and fumes may be generated. Do not enter fire area without proper protection. Firefighters should wear proper protective equipment and self-contained breathing apparatus with full facepiece. Shield personnel to protect from venting, rupturing or bursting cans. <b>Personal precautions, protective equipment and emergency procedures</b>	Absorb spillage to prevent material-damage. Restrict access to area until completion of clean-up. <b>Precautions for safe handling</b>	Wear protective gloves/ protective clothing/ eye protection/ face protection. Before handling, it is very important that engineering controls are operating, and that protective equipment requirements and personal hygiene measures are being followed. People working with this chemical should be properly trained regarding its hazards and its safe use. Inspect containers for leaks before handling. Label containers appropriately. Ensure proper ventilation. Avoid breathing dust/fume/gas/mist/vapours/spray. Avoid contact with eyes, skin and clothing. Keep away from heat, sparks and flame. Avoid generating high concentrations of dusts, vapours or mists. Keep away from incompatible materials (Section 10). Keep containers closed when not in use. Empty containers are always dangerous. <b>Conditions for safe storage, including any incompatibilities</b>	Store in a well-ventilated place. Keep container tightly closed. Keep cool. Store locked up. Store away from incompatible materials (Section 10). Inspect all incoming containers to make sure they are properly labelled and not damaged. Storage area should be clearly identified, clear of obstruction and accessible only to trained personnel. Inspect periodically for damage or leaks.
